

In 1975 the Ragdoll Society was formed with the purpose of bringing Ragdoll people together to support the Ragdoll breed. By 1978 the Society had grown to the point that the members of the Ragdoll Society felt that in order to advance the Ragdolls within the cat fancy, they would be better served by forming a Ragdoll club, and joining one of the cat associations that were available. The Ragdoll Fanciers club (RFC) was formed and officers elected. The cat association that reached out to help the RFC in it's infancy was the Cat Fanciers Federation. (CFF)

Affiliation was made with CFF because it was the first cat association to recognize the Ragdolls in all three patterns, and because it preferred that a breed be represented by a breed club.




